

Slavery and Human Trafficking Statement for FY2018

This Statement, made pursuant to Section 54 of Modern Slavery Act 2015, states the steps Sanden International (Europe) Limited ("Sanden") has taken during the fiscal year ended 31 March 2019 to ensure that slavery and human trafficking is not taking place in any part of its business and in any of its supply chains. Sanden International (Europe) GmbH made this Statement as it merged Sanden and all rights and liabilities of Sanden were transferred to Sanden International (Europe) GmbH in September 2019.

1. Sanden's business

The principal business of Sanden had been the sale and distribution of compressors for automotive air-conditioning systems and vending machines, along with the marketing of products manufactured by subsidiaries of Sanden Holdings Corporation in Japan, Sanden Manufacturing (Europe) S.A.S. in France, Sanden Manufacturing (Poland) Sp. z o.o. and SandenVendo Europe S.p.A. in Italy ("SVE"). In March 2019 Sanden sold the trade and assets of its vending machines division including all the shares of SVE to another group company within the Sanden Group, thereby completing the restructuring of its activities towards the exclusive focus on the automotive business.
